1		Revocation of Election to Pay Taxes - IRS Letter to NY	Sign in Blue Ink - Send Registered Mail, save a copy and mailing receipts. Use Green Card Return Receipt Requested for your Eternally Done and Over File. Don't need to be recorded. Use \$1.20 stamp. Sign over stamp in front of the Post Master, puts you in the UPU global status.
2		Revocation of Election to pay Taxes - IRS Letter to DC	
3		Order of Dismissal for Lack of Jurisdiction	<i>No links for this at this time...</i>
4		IRS Response letters	Used if contacted by the IRS after sending letters

#	Status	Document	Notes & Comments
1		Birth Certificate	Birth Certificate is an Insurance Indemnity Receipt (Bond) which is required under the Lieber Code/Hague Conventions. They have to give you a receipt for property they are stealing. It's essentially insurance guaranteeing that your property won't be harmed as a result of their use of it.
